RIDGE FIRE DISTRICT – BOARD OF FIRE COMMISSIONERS MINUTES OF ORGANIZATION MEETING – JANUARY 10, 2022

Meeting was called to order at 7pm by acting Secretary Teresa Anderson with a salute to the flag and a moment of silence.

Present were Commissioners Dave Hellberg, Brian Brooks, Jeffrey Campo, Rosario Lobocchiaro, Frank Mancuso. Also present Treasurer Terry Ann Lawton.

Results of the District Election that were held on December 16, 2021 are in the minute book.

Commissioner Jeffrey Campo was sworn in by Commissioner Lobocchiaro The Oath of Office was signed and will be forwarded to the Brookhaven Town Clerk. Commissioner Campo term is from January 1, 2022 to December 31, 2026.

Acting Secretary T.Anderson requested nominations for Chairman of the Board for the year 2022. Commissioner Brooks nominated Commissioner Campo and seconded by Commissioner Lobocchiaro. The Board was polled all in favor.

Acting Secretary T.Anderson requested nominations for Vice Chairman of the board for year 2022. Commissioner Brooks nominated Commissioner Lobocchiaro and seconded by Commissioner Mancuso. The Board was polled and all in favor.

The meeting turned over to Chairman Campo.

Appointments

Motion by Commissioner Brooks to appoint Teresa Anderson as District Secretary and Deputy Treasurer for the year 2022. Commissioner Hellberg seconded the motion. The Board was polled with all in favor. The yearly salary for the position is \$52,343.20.

Motion by Commissioner Lobocchiaro to appoint Terry Ann Lawton as district Treasurer for year 2022. Commissioner Mancuso seconded the motion. The Board polled with all in favor. The yearly salary for that position is \$23,390.64.

Motion by Commissioner Mancuso to appoint Christopher Ring Esq. as Attorney for the Ridge Fire District for the year 2022. Commissioner Lobocchiaro seconded the motion. The Board was polled with all in favor. The retainer for services is \$12,000, with a hourly rate of \$275.00 per hour for excluded items.

Motion by Commissioner Lobocchiaro to appoint John Boyd as EMS Coordinator for the year 2022. Commissioner Mancuso seconded this motion. The Board was polled with all in favor. The Yearly salary for this position is \$99,132.80.

Motion by Commissioner Brooks to appoint Leo Hadzigeorgiou as District Mechanic for the year 2022. Commissioner Lobocchiaro seconded the motion. The Board was polled with all in favor. The yearly salary for this position is \$105,040.00

Motion by Commissioner Lobocchiaro to appoint Sharon Farina as Custodian for the year 2022.Commissioner Mancuso seconded the motion. The Board was polled with all in favor. The yearly salary for this position is \$32,947.20.

Board approves the following ten paid holidays for full time employees. New Years day, Martin Luther King Day, Presidents Day, Memorial Day, Independence Day, Labor Day, Columbus Day, Veterans Day, Thanksgiving Day, and Christmas Day.

The Ridge Fire District offers all employees the opportunity to join the New York State Employee Retirement system upon completion of probationary period. All full time employees are offered health insurance thru NYSHIP if they choose.

Motion by Commissioner Lobocchiaro to appoint Winston Lee as NYS Instructor Coordinator for 2022. Commissioner Mancuso seconded the motion. The Board polled with all in favor. The rate of pay is \$55.00 a hour.

Motion by Commissioner Lobocchiaro to appoint Jones and Little as Accountant for the fire district. Commissioner Brooks seconded the motion. The Board polled in favor.

Administrative

Motion by Commissioner Lobocchiaro to designate Capital One as Districts Official Depository. J.P Chase Bank and Depository Trust Corp, as paying agents for bonds seconded by Commissioner Brooks. The Board was polled with all in favor.

Motion by Commissioner Brooks to designate Newsday as the district's official newspaper and have all official notice published in same. Seconded by Commissioner Hellberg. The Board was polled with all in favor.

Motion by Commissioner Brooks to hold regular monthly meetings of the Ridge Fire District on the second Monday of each month at 7:30pm. If said meeting falls on a holiday, the Board can move said meeting to the following Tuesday or cancel same. The Board will hold a second meeting on the fourth Sunday of each month at 9am, seconded by Commissioner

Mancuso. The Board was polled with all in favor. Attorney Christopher Ring will publish yearly meetings in Newsday. Meetings of the Board of Fire Commissioners will be held at Ridge Fire District Station 3, 46 Panamoka Trail, Ridge until such time that the headquarters building at 20 Frances Mooney Drive, Ridge is completed. Thereafter, meetings will be held in the Commissioners meeting room at that location. The Board of Fire Commissioners reserves the right to hold meetings electronically if a public health situation requires same in accordance with NYS Executive Law.

Motion by Commissioner Lobocchiaro to continue membership in the following organizations for the year 2022 and paid dues as statements received. Motion by Commissioner Hellberg to enter into contract with Brookhaven Town Highway Department for salt and sand for the year 2022. Seconded by Commissioner Brooks. Board polled all in favor.

Motion to accept Adept Technology for the year 2022 made by Commissioner Hellberg seconded by Commissioner Lobocchiaro Board polled all in favor. Departmental
